Sub: **Flight Radiotelephony Operating (FRTTO) Endorsement in the Licence in respect Bangladeshi Pilots.**

Dear Sir,

It is intimated that with immediate effect as per ICAO Annex1, Chapter-1, section-1.2.9 & ICAO Annex-6, Chapter-9, section-9.1.2 and Rules 9 (1) & 57A of CAR'84 shall be implemented and the endorsement if "ELP Level with date" is to be continued and additionally FRTTO Licence endorsement shall be inserted in the Pilot Licence urgently by CAAB as follows:

- a) Item XIII: "The holder is RT competent."
 - b) Item XIII: "ELP with level and date."
02. It may be noted that the procedure of the subject matter shall be made as follows:
- i) Operator/School should develop training program for 1.a and 1.b to the best satisfaction of CAAB at the earliest.
 - ii) Operator should include a point on pilots competence to operate R/T equipment on board the aircraft' in the PPC checklist at the earliest.
 - iii) The Flight Crew previously holding FRTOL shall present/produce the same to CAAB for their endorsement (1.a).
