SUBJECT: CIRCULAR ON NATIONAL CIVIL AVIATION SECURITY QUALITY CONTROL PROGRAMME (NQCP), 2ND EDITION.

The People's Republic of Bangladesh is a signatory to the Convention on International Civil Aviation (Chicago Convention 1944) and is, therefore, obliged to implement the standards adopted by the International Civil Aviation Organisation (ICAO).

As required by the standard 3.4.4 of Annex 17, the Civil Aviation Authority of Bangladesh (CAAB) is required to develop, implement and maintain a national civil aviation security quality control programme to determine compliance with and validate the effectiveness of the national civil aviation security programme of Bangladesh.


The NCASQCP is a fundamental component of a State's aviation security oversight system with the objective of assessing the effective implementation of quality control measures. This programme outlines the duties and responsibilities of CAAB as the appropriate authority for aviation security in Bangladesh and the regulated entities responsible for implementing provisions of national civil aviation security programme.

This programme was developed and made available to concerned entities in 2014 as the first edition. This programme is a living document and subject to amendment in response to changes to international and national obligations and threat and risk.

CAAB has developed the 2nd edition of this programme which is approved by the Chairman, CAAB and available for distribution. This programme appended by 17 (seventeen) Appendices. Distribution of some appendices is limited to national aviation security inspectors and other authorized persons only. The 2nd edition of this programme will be effective from **1st September 2018**.
