### CIVIL AVIATION CIRCULAR(CAC-AT) 01/2020

## Sub: Night Operation by Helicopter within Bangladesh Territory.

This is to inform you that, based on the commercial requirements of the operators, night operation by helicopter is to be conducted as per the following conditions:

- a. night commercial/training flight has to be operated under IFR only;
- b. no night VFR commercial/corporate flights are to be operated;
- c. flight can be operated only from one Airfield to another operational Airfield of CAAB and within the operational hours of those airfield;
- d. alternate Airfield(s) should also be operational during the flight;
- e. night VFR training flight may be conducted within 10 nm around the operational airfields/heliports;
- f. radio Telephony facilities, NAV aids and other essential facilities for the flight must be available at departure, destination and alternate airfield(s);
- g. "Low visibility procedures for Domestic Helicopter Operation Circular CAC-3" shall be complied;
- h. flight should be operated by two qualified pilots;
- i. standard separation applicable to IFR flights shall be maintained; and
- j. this clearance will be applicable only for IFR certified Helicopter.

Helicopter Operators shall abide by the above conditions strictly while conducting any night operation within Bangladesh territory.
