Request for Expression of Interest (EOI) from Consulting Law Firm


Civil Aviation Authority of Bangladesh (CAAB) intends to formulate rules under Civil Aviation Act-2017 & Civil Aviation Authority Act-2017 with a view to enhance regulation for safe and smooth operation of aircrafts as well as to help the promotion of air safety of the country. The Drafting of Rules (Separate rules for both Acts) under the light of Civil Aviation Act 2017 and Civil Aviation Authority Act 2017 on the basis of existing Civil Aviation Rules-1984 . Necessary Correction, addition, subtraction i.e correlation new draft rules /Act preparation that include the following:

- i) At the time of preparation of "Formulation of Rules under Civil Aviation Act -2017" The Consultancy service Provider formulate and include the necessary parts of 19 numbers of Appendixes of Chicago Convention as Standard and Recommendation Practices (SARPs) and 2017 Civil Aviation Authority Acts. In Consideration of other International Organization like FAA, EASA rules , regulation and relating acts the consultancy Firm will prepare the draft for Formulation of Rules under Civil Aviation Law-2017
- ii) The Existing Civil Aviation Rules-1984 rules in English Language. As per International Convention in case of International Flight Movement Conventional Technical terms & its abbreviation should applicable properly at the time of draft preparation for "Formulation of Rules under Civil Aviation Law-2017. The draft rules should prepared English Language and Bangla Language simultaneously.
- iii) The Consultancy Firm should formulation and adopting necessary part of ICAO Annex-19 newly in the proposed service.
- iv) At the time of Completion the service "Formulation of Rules under Civil Aviation Act -2017" The consultancy service provider personals co-ordinates with Civil Aviation Authority of Bangladesh nominated Focal Person and if necessary with respective Officer/Consultant/ Special Inspector etc..
