Civil Aviation Authority, Bangladesh (CAAB) functions as the regulatory body for all aviation related activities in Bangladesh. It is also the aeronautical service provider and is responsible for safe, expeditious and efficient flow of air traffic within the flight information Region (FIR) bounded by the international geographic boundary of Bangladesh. There are 8 (eight) operating Airports in the country and Cox's Bazar Airport is one of them. Cox's Bazar city is situated by the Bay of Bengal and is one of the most important tourism city in the country. Civil Aviation Authority of Bangladesh has taken a project in hand named "**Development of Cox's bazar Airport (Phase-II)**" to upgrade the overall operational and passenger movement facilities of the said Airport.
