COMMERCIAL PILOT LICENSE (Aeroplane/Helicopter) :

ISSUE

A) Requirements:-

1. Age not less than 18 years
2. Educational Qualification-HSC (Science) with Physics and Mathematics or Equivalent
3. Medical fitness (Class-I)
4. Ground Course from an ATO
5. CPL Theory examinations (9 subjects)
6. Type Technical examinations (if applicable)
7. Flying Experience as mentioned below in section-(C)
8. Oral Test
9. Skill test/Flight test (before skill test, CAAB's permission is required)
10. Aviation English Language Proficiency Level (Minimum Level 4 or higher) ;

B) Supportive documents to be submitted:-

1. Duly filled up CA form-24(I) or 29(I) of ANO (OPS) A5
2. Ground Course
3. Documents and checks/evaluation reports including x-city certificate as mention in the item-(C)
4. Flying Logbook
5. Flying Experience Documents and NOC from Military (if applicable)
6. Two passport size and two stamp size photographs with white background
7. Bio-data
8. National ID Card/ Birth Certificate/Passport (Photocopy)
9. Security Clearance (if applicable)
10. Letter from an Approved Training Organaigation including all documents mentioned in the (A), (B) and necessary fees as mentioned in section-(D) ;

C) Flying experience:-

Aeroplane Category:

- (i) 200 hours of flight time, or 150 hours if completed during a course of approved training
- (ii) 100 hours as pilot-in-command or, in the case of a course of approved training, 70 hours as Pilot-in-command;
- (iii) 20 hours of cross-country flight time as pilot-in-command including a cross country flight totaling not less than 540 km (300 NM);
- (iv) 10 hours of instrument instruction time of which not more than 5 hours may be instrument ground time; and
- (v) If the privileges of the license are to be exercised at night, 5 hours of night flight time including 5 take-offs and 5 landings as pilot-in command.

For more details please refer Rule-24(3) of CAR'84 and Section-9.1(b)(c)&(d) of ANO(OPS) A-5.

Helicopter Category:

- (i) 150 hours of flight time, or 100 hours if completed during a course of approved training
- (ii) 35 hours as pilot-in-command
- (iii) 20 hours of cross-country flight time as pilot-in-command including a cross country flight totaling not less than 540 km (300 NM);
- (iv) 10 hours of instrument instruction time of which not more than 5 hours may be instrument ground time; and
- (v) If the privileges of the licence are to be exercised at night, 5 hours of night flight time including 5 take-offs and 5 landings as pilot-in command.

NB-

- (i) In addition to the above, any other charges relate to the medical examination shall be paid to the hospital/diagnostic centre.
- (ii) Candidates, who have military experience, need to pay amount of Tk.2500/- for each theoretical subjects. Before proceeding for medical, ground and flying training, candidate need to apply for permission according to the ANO(OPS) A-4.

E) Procedure:-

1. Visit the Personnel Licensing Section with the original documents and make the relevant payment to commence the process of evaluation of the application.
2. Fees should be deposited to Finance Department of CAAB and the Chalan/Money Receipt has to be enclosed with the license application.
3. The requirements and necessary forms for issuance of Commercial Pilot Licences have been published in ANO(OPS) A-5 which is available in the CAAB website.
4. Necessary fees will be applicable for Medical examination, AELP Test, Aircraft Rating and theoretical examination
5. For Medical Examination, applicants are to be contact with Medical Assessor at Headquarters of CAAB.
6. AELP Test is held on CAAB HQ.
7. CAAB conducts CPL Exam through CBE (Computer Based Examination) system at Headquarters. For examination registration, applicants may visit ASRTM in CAAB website (www.caab.gov.bd-ASRTM-Computer Based Examination for Personnel Licensing-Registration).

COMMERCIAL PILOT LICENSE (Aeroplane/Helicopter) : RENEWAL/REVIVAL

A) Requirements:-

1. Valid Medical Certificate (Class I)
2. Air Law and Type Refresher Course by operator/organization
3. CPL Theory examinations (if applicable)
4. Type Technical examinations (Specific Type)
5. Flying Experience as mentioned below in section-(C)
6. PPC (Including IR check on aircraft or simulator)/Skill test/Flight test (if required)
7. Updated AELP Level (Minimum Level 4); **and**

additional experience required for Scheduled Air Transport Aircrew as follows :

- (i) Type Technical Refresher Training as per company policy (CAAB approved)
- (ii) CRM Course as per company policy (CAAB approved)
- (iii) SEEP Course as per company policy (CAAB approved)
- (iv) CFIT refresher as per company policy. (CAAB approved)
- (v) Route check. (CAAB approved)

B) Supportive documents to be submitted:-

1. Duly filled up CA form-24(R) or 29(R) of ANO (OPS) A-5
2. Ground Course certificate
3. Theoretical Examination Result (if applicable)
4. Documents and check/evaluation reports as mention in the item-(A)
5. Flying Logbook
6. Letter from an Approved Training Organization/Operator including all documents mentioned in the (A), (B) and necessary fees as mentioned in section-(D);

C) Experience:-

Aeroplane:

- (i) PPC with IR check
- (ii) 3 take-offs & 3 landings during the last 12 months from the date of application provided that 1 night take-offs and 1 landings within 90.
- (iii) For revival of CPL, requirements to be fulfilled as per circular-CAAB/1718/5/FI(V-11), Date: 13.03.2008

Helicopter :

- (i) PPC with IR check
- (ii) Flight Test in helicopter
- (iii) 3 take-offs & 3 landings during the last 12 months from the date of application provided that 1 night take-offs and 1 landings within 90 days from the date of application.
- (iv) For revival of CPL, requirements to be fulfilled as per circular-CAAB/1718/5/FI(V-11), Date: 13.03.2008

D) Relevant Fees:

- (i) For CPL(A)/CPL(H) for renewal/revival Tk.5000/-

E) Procedure:-

1. Visit the Personnel Licensing Section with the original documents and make the relevant payment to commence the process of evaluation of the application.
2. Fees should be deposited to Finance Department of CAAB and the Chalan/Money Receipt has to be enclosed with the license application.
3. The requirements and necessary forms for renewal/revival of Commercial Pilot Licences have been published in ANO(OPS) A-5 which is available in the CAAB website.
4. For Medical Examination, applicants are to be contact with Medical Assessor at Headquarters of CAAB.
5. Necessary fees will be applicable for Medical examination, AELP Test, Aircraft Rating and theoretical examination
6. AELP Test is held on CAAB HQ.
7. CAAB conducts CPL examination through CBE (Computer Based Examination) system at Headquarters. For examination registration, applicants may visit ASRTM in CAAB website (link: www.caab.gov.bd-ASRTM-Computer Based Examination for Personnel Licensing).
